Sealed Bids for Anthony Wayne Trail Water Main Crossing Emergency Replacement, will be received by the Director of Public Service, in his office at 400 Conant Street, Maumee, Ohio, until 10:00 a.m., local time, on November 1, 2017, at which time they will be publicly opened and read.

In general, the work consists of the replacement of the existing 10-inch water main crossing the Anthony Wayne Trail, paralleling the former alignment of Monclova Road. The new crossing will be constructed as a 12-inch diameter pipe using trenchless methods.

The successful bidder will be required to furnish satisfactory Performance Bond and Maintenance and Guarantee Bond in the amount of 100% of the Bid.

The Contractor shall be required to pay not less than the prevailing wage rates established by the Ohio Bureau of Employment Services, Wage and Hour Division.

Any Bid may be withdrawn prior to the scheduled closing time for receipt of Bids, but no bidder shall withdraw his Bid within 90 days after the actual opening thereof.

The Owner reserves the right to reject any or all Bids, waive irregularities in any Bid, and to accept any Bid which is deemed most favorable to the Owner.
